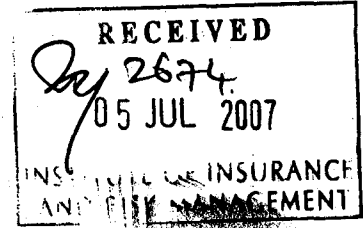

Re: Exemption in the Associateship Examinations of Insurance Institute of India:

Please refer to your previous correspondence regarding the above.

In this connection, we would like to inform you that the matter has been placed before the Competent Authority of our institute and now we are pleased to inform you that the competent Authority has decided to grant the exemption from entire Licentiate, Life or Non- Life Branch and entire Associateship Life or Non-life (General Branch) to the candidates who have completed two year Post Graduate Diploma in Life, General Insurance and Risk Management Program from Indian Institute of Risk Management Hyderabad on following Terms and Conditions:

This with one year's arrears is marked

1. Candidates should pass the above mentioned examination with minimum 50% marks.
2. Original and zerox copy of mark sheet be enclosed with the normal examination entry form for fellowship with a covering letter for claiming exemption from entire Licentiate and Associateship examination through IIRM Hyderabad.

3. The candidate will be required to pay the membership fees, exemption fees for both the examinations i.e. Licentiate and Associateship, registration fees and other charges as may be payable by them as per rules of the Institute in force from time to time.
4. Candidates who have completed the above program in Life Branch will be Exempted from appearing for Licentiate and Associateship examination in Life Branch, similarly, candidates who have completed the above programs in Non -Life Branch will be exempted from appearing for Licentiate and Associateship Examination in General branch only. Irrespective of the subjects selected by him (candidates will not get Exemption in Associateship Examination for Fire Marine and Miscellaneous branches) any further specialization at the Associateship level will only be subject to candidate appearing for the examination.
5. Apart from the above, the most important and essential condition is that the exemption from Associateship will be effective only after the prospective candidate should pass atleast one subject of the Fellowship examination.
6. An application for exemption will be entertained only when forwarded by IIRM Hyderabad certifying that the candidate has passed the requisite qualification giving particulars of Roll Number, Year of passing, name of qualification and also certifying that the candidate is eligible as per conditions of Insurance Institute of India for exemption in Associateship Examination
